- 2. Costs of photographic documentation use ranges from \$25.00 to \$1500.00 (US) per photograph. Film documentation ranges from \$250.00 to \$1500.00 (US) per minute. Other costs may be applied if the documentation is used for fund raising purposes.
- 3. Credit must be given as Lifeforce/Peter Hamilton © lifeforcefoundation.org on each photograph and verbally and/or designated on each film segment.
- 4. All rights and copyright are not transferable and remain with Peter Hamilton and Lifeforce. All film/photographs cannot be sold, given or used by any other parties and/or cannot be used for any other purposes other than the agreed use as stated below. Any violation of Lifeforce and/or Peter Hamilton's rights and/or copyrights is subject to a minimum fee of \$10.000 (US).
- 5. Photograph/Film documentation and all other duplicated materials of the photographs/film shall be returned to Lifeforce within 30 days of receipt. Photographs/film material or and duplicates of shall not be kept by the borrower. A sample of the agreed use shall be provided to Lifeforce at no cost.
- 6. A research fee of \$50.00 to \$200.00 (US) may be charged in order to cover any expenses arising from any reproduction, time/travel costs to obtain and prepare documentation, photocopying of documentation and postage/shipping costs.
